

Code of Conduct

This Code of Conduct applies to the Jacado Games website, available at <https://jacado.games>, including its games, scoreboards, hall-of-fame features, account-related features, user-submitted information, communications with Jacado Games, and any related online functionality made available through the website (collectively, the "Website").

Jacado Games is intended to provide a fair, safe, respectful, and enjoyable environment for casual logic-puzzle games and related online participation. By accessing or using the Website, submitting a score, appearing in a hall of fame, contacting Jacado Games, or otherwise interacting with the Website, you agree to follow this Code of Conduct. This Code of Conduct may be updated at any time, and continued use of the Website means acceptance of the updated version.

This document is designed to protect users and to protect Jacado Games from misuse, abuse, manipulation, harassment, unfair play, operational disruption, and legal or reputational risk. Jacado Games may interpret and enforce this Code of Conduct at its discretion, subject to applicable law.

1. Expected Behavior

Users are expected to use Jacado Games in a reasonable, respectful, lawful, and fair manner. Users should help maintain a positive game environment and avoid conduct that harms other users, the Website, or Jacado Games.

- Use the Website for its intended purpose: playing games, improving skills, and enjoying score-based competition fairly.
- Respect other users, including users who appear in scoreboards or hall-of-fame areas.
- Submit only accurate, lawful, and appropriate information when interacting with the Website.
- Use appropriate names, aliases, email addresses, and other submitted details.
- Report suspected bugs, abuse, cheating, security issues, or harmful behavior responsibly.
- Follow all applicable laws, this Code of Conduct, the Terms and Conditions, the Privacy Policy, and any instructions published on the Website.

2. Unacceptable Behavior

The following behavior is prohibited. The list is not exhaustive. Jacado Games may treat similar or related behavior as a violation even if it is not specifically listed below.

- Harassment, threats, intimidation, bullying, hate speech, discriminatory language, abusive language, degrading language, or personal attacks.
- Content or behavior targeting a person or group based on race, religion, nationality, ethnic origin, gender, gender identity, sexual orientation, disability, age, physical appearance, or any other status protected by applicable law.
- Sexual, obscene, violent, defamatory, illegal, misleading, or otherwise inappropriate content in names, score entries, hall-of-fame entries, messages, email communications, or any submitted information.
- Impersonation of another person, organization, Jacado Games representative, or public figure.
- Submitting another person's email address or personal information without authorization.
- Using the Website in a way that could expose Jacado Games or other users to legal, security, privacy, or reputational harm.
- Attempting to evade enforcement actions, restrictions, bans, score removals, or account limitations.

3. Fair Play, Scores, and Hall of Fame

Scores, rankings, and hall-of-fame entries are intended for fair play. Jacado Games may review, remove, hide, correct, reset, or refuse scores or hall-of-fame entries at any time, including when a score appears inaccurate, manipulated, abusive, suspicious, technically invalid, or inconsistent with fair use of the Website.

- Cheating, automation, bots, scripts, macros, game-state manipulation, network manipulation, browser-console manipulation, artificial score generation, reverse engineering for score manipulation, or any other unfair method is prohibited.
- Users must not exploit bugs, timing defects, browser behavior, server behavior, or client-side weaknesses to obtain unfair scores or advantages.
- Users must not submit false, offensive, misleading, promotional, spam-like, or privacy-invasive hall-of-fame information.

- Jacado Games has no obligation to publish, preserve, investigate, explain, or restore any score or hall-of-fame entry.
- Jacado Games' decisions regarding score validity, ranking, hall-of-fame inclusion, and enforcement are final, unless mandatory law requires otherwise.

4. Security and Technical Misuse

Users must not interfere with, damage, overload, disrupt, scan, test, bypass, reverse engineer, or attempt to gain unauthorized access to the Website, its infrastructure, its data, its source code, its APIs, its scoring systems, or any related system.

- No hacking, probing, credential attacks, scraping, data harvesting, denial-of-service activity, malware, unauthorized automation, or circumvention of security measures.
- No attempt to access, extract, modify, corrupt, delete, or manipulate data that does not belong to the user.
- No use of the Website to distribute spam, malware, phishing content, unlawful content, or deceptive material.
- No exploitation of implementation defects or unintended behavior for personal, competitive, financial, or reputational advantage.
- Security issues should be reported responsibly and must not be publicly exploited or used to harm Jacado Games or its users.

5. User-Submitted Content and Communications

Any name, email address, score-related data, message, support request, feedback, bug report, suggestion, or other information submitted to Jacado Games must be lawful, accurate, appropriate, and submitted by someone authorized to provide it. Users are responsible for the content they submit.

Jacado Games may remove, edit, hide, refuse, or retain user-submitted content where necessary to operate the Website, enforce this Code of Conduct, protect users, prevent abuse, comply with law, preserve evidence of misconduct, or protect Jacado Games. Submission of feedback or suggestions does not create any obligation, compensation right, ownership claim, or confidentiality obligation unless expressly agreed in writing by Jacado Games.

6. Children and Minors

Jacado Games may be used by people of different ages, subject to the Terms and Conditions and applicable law. Users who are minors should use the Website only with appropriate parental or guardian involvement where required. Parents and guardians are responsible for supervising minors' online activity and for deciding whether Jacado Games is appropriate for them.

Users must not knowingly submit personal information of a child or another minor without the required authorization. Jacado Games may remove or restrict content, scores, or access where it believes that a minor's privacy, safety, or legal rights may be affected.

7. Reporting Violations

Users who believe that this Code of Conduct has been violated may contact Jacado Games using the contact details published on <https://jacado.games>. Reports should include enough information to understand the issue, such as the relevant game, score, hall-of-fame entry, date, screenshot, browser/device information, and a clear description of the concern.

Jacado Games may review reports at its discretion. Jacado Games is not required to provide a detailed explanation, disclose internal security or enforcement methods, mediate disputes between users, or respond to every report. However, Jacado Games may use reports to improve safety, fairness, and reliability.

8. Enforcement

Jacado Games may take any action it considers appropriate to protect the Website, users, and Jacado Games. Enforcement may occur with or without prior notice, depending on the severity, urgency, or nature of the issue.

- Warning a user or requesting that behavior stop.
- Removing, editing, hiding, refusing, correcting, or resetting scores, names, aliases, emails, hall-of-fame entries, or other submitted content.
- Restricting, suspending, terminating, or blocking access to the Website or selected features.
- Disabling premium access or account-related benefits where misconduct, payment abuse, fraud, or violation of applicable policies is suspected.
- Preserving relevant logs, records, communications, or technical information for investigation, legal, operational, or security purposes.

- Reporting serious, illegal, harmful, or security-related behavior to service providers, payment providers, app marketplaces, hosting providers, law-enforcement authorities, or other relevant parties where appropriate or legally required.

9. No Duty to Monitor

Jacado Games may, but is not required to, monitor user behavior, scores, submissions, hall-of-fame entries, or communications. Failure to detect, remove, or act against a violation does not waive Jacado Games' right to enforce this Code of Conduct later. Jacado Games does not guarantee that all misconduct, cheating, offensive content, technical abuse, or inaccurate scores will be detected or removed.

10. Relationship with Other Policies

This Code of Conduct operates together with the Jacado Games Terms and Conditions, Privacy Policy, Refund Policy, Accessibility Declaration, and any other policies or instructions published by Jacado Games. If there is a conflict between this Code of Conduct and the Terms and Conditions, the Terms and Conditions will apply to the extent of the conflict, unless mandatory law requires otherwise.

11. Changes to This Code of Conduct

Jacado Games may update this Code of Conduct from time to time. The updated version will apply from the date it is published or otherwise made available. Users should review this document periodically. Continued use of the Website after publication of an updated version means acceptance of the updated Code of Conduct.
