

Terms and Conditions

Welcome to Jacado Games.

These Terms and Conditions ("Terms") govern your access to and use of the Jacado Games website, online games, scoreboards, hall-of-fame features, related pages, and any other services made available through <https://jacado.games> (collectively, the "Service").

By accessing or using the Service, you agree to be bound by these Terms. If you do not agree with these Terms, you must not access or use the Service.

1. Description of the Service

Jacado Games provides casual online games and related features, which may include game play, score tracking, top-score tables, hall-of-fame displays, game pages, and other entertainment-related functionality.

Jacado Games may modify, update, suspend, restrict, or discontinue any part of the Service at any time, with or without notice, including games, features, scoreboards, hall-of-fame entries, rules, limits, or availability.

2. Eligibility and Use by Minors

The Service is intended for users who are legally permitted to use online games and websites under the laws that apply to them.

If you are a minor, you may use the Service only with the permission and supervision of a parent or legal guardian. Parents and legal guardians are responsible for the activity of minors who use the Service.

Jacado Games does not knowingly require users to provide personal information in order to play the games, except that an email address may be associated with a top score shown in the hall of fame, as described in the Privacy Policy.

3. Hall of Fame, Scores, and Rankings

The Service may allow users to submit or display scores, rankings, nicknames, identifiers, and hall-of-fame entries. Scores and rankings are provided for entertainment purposes only.

Jacado Games has no obligation to publish, maintain, preserve, verify, or restore any score, ranking, or hall-of-fame entry. Jacado Games may remove, hide, edit, reset, refuse, or disqualify any score or entry at its sole discretion, including where Jacado Games suspects cheating, automation, manipulation, technical error, offensive content, impersonation, misuse, or any other conduct that may harm the Service or other users.

A hall-of-fame entry does not create any right, prize, payment, property interest, or entitlement unless Jacado Games expressly states otherwise in writing.

4. User Responsibilities and Acceptable Use

By using the Service, you agree that you will not:

- use the Service for any unlawful, harmful, fraudulent, abusive, or unauthorized purpose;
- submit false, misleading, offensive, defamatory, obscene, hateful, harassing, threatening, or infringing content;
- attempt to manipulate, falsify, inflate, automate, scrape, or otherwise interfere with scores, leaderboards, rankings, or hall-of-fame entries;
- use bots, scripts, automated clients, emulators, exploits, hacks, reverse engineering, packet manipulation, or other technical means to gain an unfair advantage;
- attempt to bypass security, access controls, rate limits, or technical restrictions;
- interfere with the operation, integrity, performance, availability, or security of the Service;
- upload, transmit, or introduce malware, spam, harmful code, or excessive requests;
- copy, reproduce, distribute, sell, sublicense, frame, mirror, or commercially exploit the Service without written permission;

- use the Service in a way that violates third-party rights, including intellectual property, privacy, publicity, or contractual rights.

You are responsible for all activity that occurs through your device, browser, connection, or identifiers when using the Service.

5. User Content and Submissions

Any nickname, display name, score, ranking, message, feedback, bug report, suggestion, or other material submitted to or through the Service is referred to in these Terms as "User Content."

You represent that you have the right to submit your User Content and that your User Content does not violate these Terms or the rights of any person or entity.

By submitting User Content, you grant Jacado Games a worldwide, non-exclusive, royalty-free, sublicensable, transferable license to host, store, reproduce, display, publish, modify, moderate, remove, and otherwise use that User Content for operating, improving, protecting, and promoting the Service.

Jacado Games may remove or modify User Content at any time and is not required to monitor or preserve User Content.

6. Intellectual Property

All rights, title, and interest in and to the Service, including the games, game mechanics as implemented, software, source code, object code, design, graphics, icons, names, logos, text, audio, visual elements, layouts, databases, score systems, and other materials, are owned by Jacado Games or its licensors and are protected by applicable intellectual property laws.

Except for the limited right to access and use the Service for personal, non-commercial entertainment in accordance with these Terms, no right or license is granted to you.

11. Privacy

As a general principle, Jacado Games aims to minimize personal data collection. The only private data currently kept is the email address associated with a top score shown in the hall of fame. Apart from that, Jacado Games does not intentionally keep private data, as further described in the Privacy Policy.

12. Security

Jacado Games may take technical and legal action to protect the Service, including blocking access, removing entries, rate limiting, preserving logs for security purposes where legally permitted, investigating misuse, and cooperating with service providers or authorities when appropriate.

Jacado Games may delete or disable scores, rankings, hall-of-fame entries, User Content, identifiers, or access credentials associated with misuse. You may stop using the Service at any time.

17. Changes to These Terms

Jacado Games may update these Terms from time to time. Updated Terms may be published on the website with a revised "Last updated" date or otherwise made available through the Service.

Your continued use of the Service after updated Terms become effective means that you accept the updated Terms. If you do not agree to the updated Terms, you must stop using the Service.

18. Governing Law and Disputes

Unless otherwise required by applicable law, these Terms shall be governed by and interpreted in accordance with the laws of the State of Israel, without regard to conflict-of-law principles.

Unless otherwise required by applicable law, the competent courts located in Tel Aviv, Israel, shall have exclusive jurisdiction over any dispute, claim, or proceeding arising out of or relating to these Terms or the Service. You agree to submit to the personal jurisdiction of those courts.

19. Miscellaneous

These Terms, together with the Privacy Policy and any additional rules published by Jacado Games for specific games or features, constitute the entire agreement between you and Jacado Games regarding the Service.

If any provision of these Terms is found to be invalid or unenforceable, the remaining provisions will remain in full force and effect, and the invalid or unenforceable provision will be interpreted or replaced to achieve the closest lawful result.

Jacado Games failure to enforce any provision of these Terms is not a waiver of its right to do so later.

You may not assign or transfer your rights or obligations under these Terms without prior written permission. Jacado Games may assign or transfer its rights and obligations in connection with a merger, acquisition, sale of assets, reorganization, operation of law, or otherwise.
